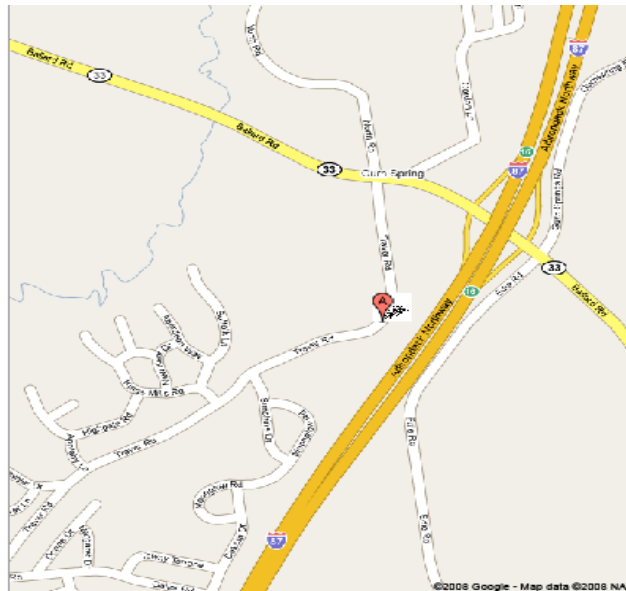


## Budget Deadlines

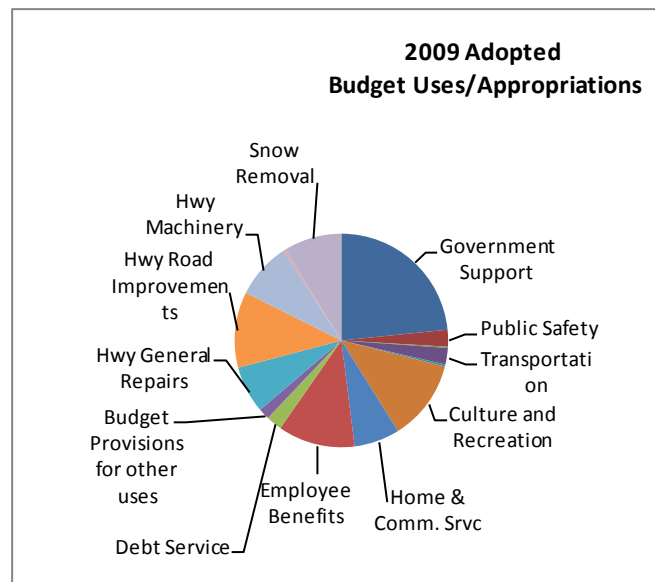
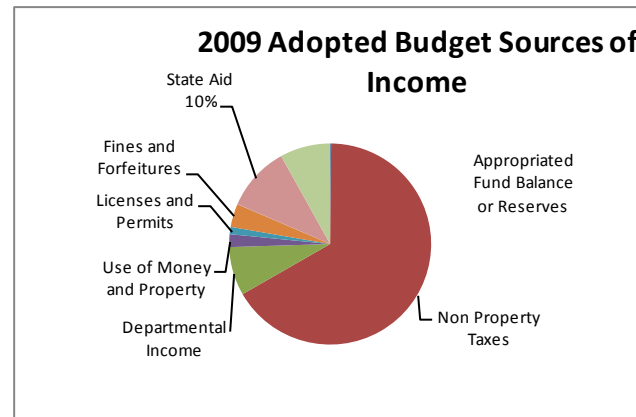


Receptionist Carrie Fisher joined the Town in 2005. Carrie is the first person that you see when you walk into Town Hall.
